From our CEO, Tanya Hilgendorf

As you know, animals can't speak for themselves; they need us to advocate for them. And in 2024, we certainly did.

From meeting with legislators and providing expert testimony in Lansing to gathering locally with animal advocates and educating others working in animal welfare, HSHV helped lead crucial efforts to protect animals across the state.

Every day, with your generosity and support, HSHV provides essential care—rescuing, sheltering, and finding loving homes for animals in need. Yet, an equally critical part of our mission involves advocacy and education: working "upstream" to prevent harm, cruelty, and homelessness before they happen.

Through legislation and community education, we strive not just to react to animal suffering, but to prevent it. Advocacy is key—changing laws, shifting attitudes, and creating protections for animals that stop cruelty before it starts.

But 2024 wasn't without big challenges. At the year's end, Michigan's House was unable to vote, leaving hundreds of bills to expire—including many critical bills we worked so hard to advance, including:

- Pet license plate (funding spay/neuter and supporting shelters)
- Cat declaw ban
- Animal Bond and Forfeiture (streamlining placement of cruelty-case animals into loving homes)
- Queenie's Law (ending painful experiments on dogs)
- Veterinary telehealth expansion (improving access to care)
- Ban on pet stores selling dogs, cats, and bunnies
- Greater protections for outdoor dogs

Tragically, not a single meaningful animal-friendly bill passed. At times, it might feel like these efforts don't matter. But as someone who's dedicated two decades to animal protection, I can assure you—it does. Every voice, every effort, and every step forward is essential, even when progress feels painfully slow.

As Theodore Roosevelt once said, "Nothing worth having comes easy." At HSHV, we will never give up and we hope you won't either. Together, we'll continue advocating, educating, caring, and loving; knowing that our collective efforts are building a safer, kinder future for all animals.

Buddies Freeling and Tartt share a life-threatening medical condition.

"Funnel chest" means their rib cages curved inward, leaving scant room for their hearts and lungs to grow. It's rare to see kittens with this condition. And two at the same time? They were lucky to have each other-- and you.

While "funnel chest" is often fatal, **thanks to supporters like you, and foster parents who donate their time and loving care**, both Freeling and Tartt received lifesaving specialty surgery, and the time they needed to find loving families where they can grow up.

ADVOCACY FOR THE FUTURE

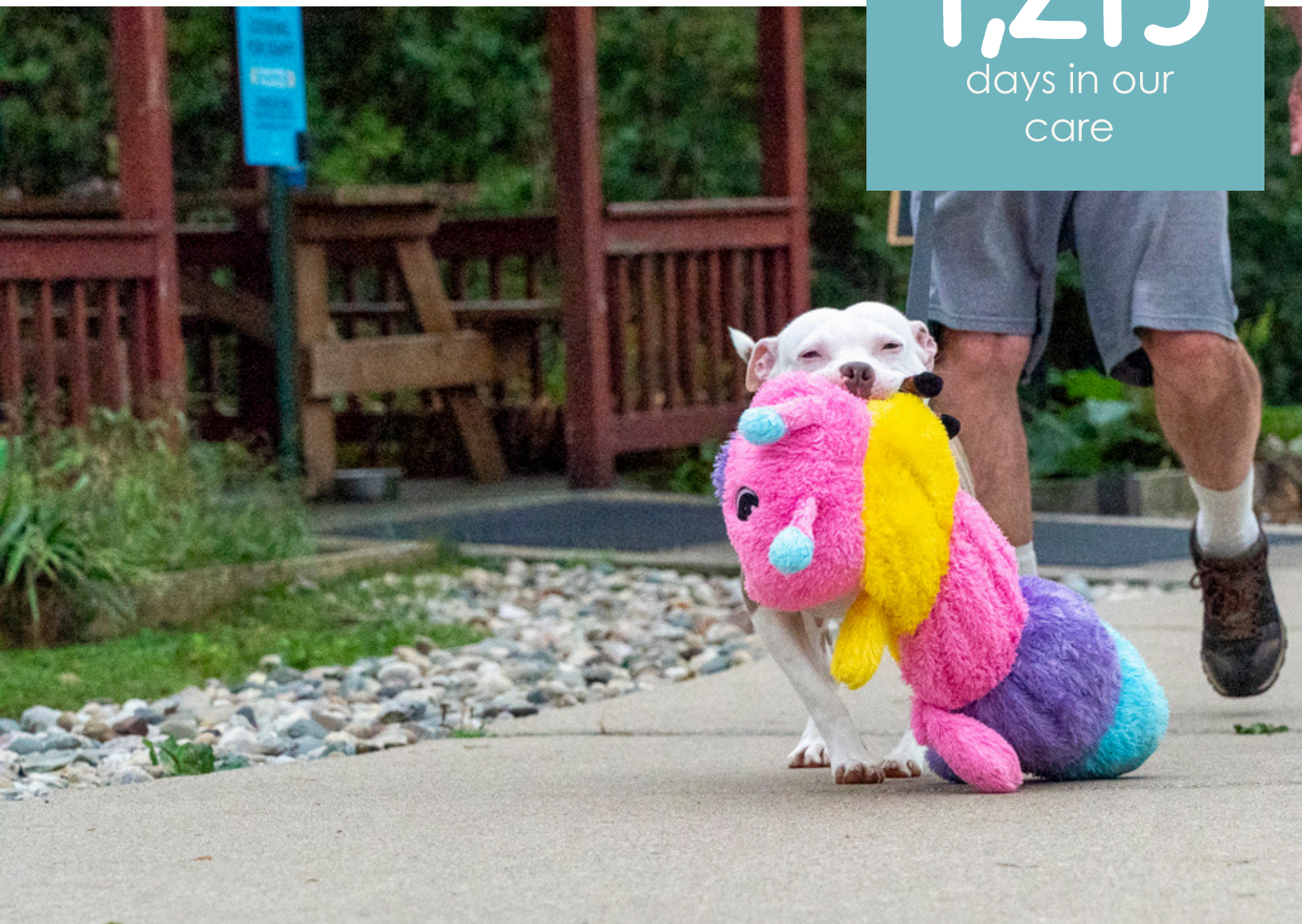
We took care of Titi nearly her whole life. In June 2021, when she was just 7 months old, she was rescued from an abusive owner. This October, her owner was found guilty of animal cruelty, and Titi was finally released to find a new home.

Staff and volunteers fell in love with her, seeing her grow from a timid puppy to a happy dog, trying to do the best job we could raising her in a shelter, when we really knew she deserved a home.

We will continue to advocate for laws to help animals just like Titi.

After seeing how loving and affectionate she was in just a few short days, we knew that we would never make her spend another day in a shelter.

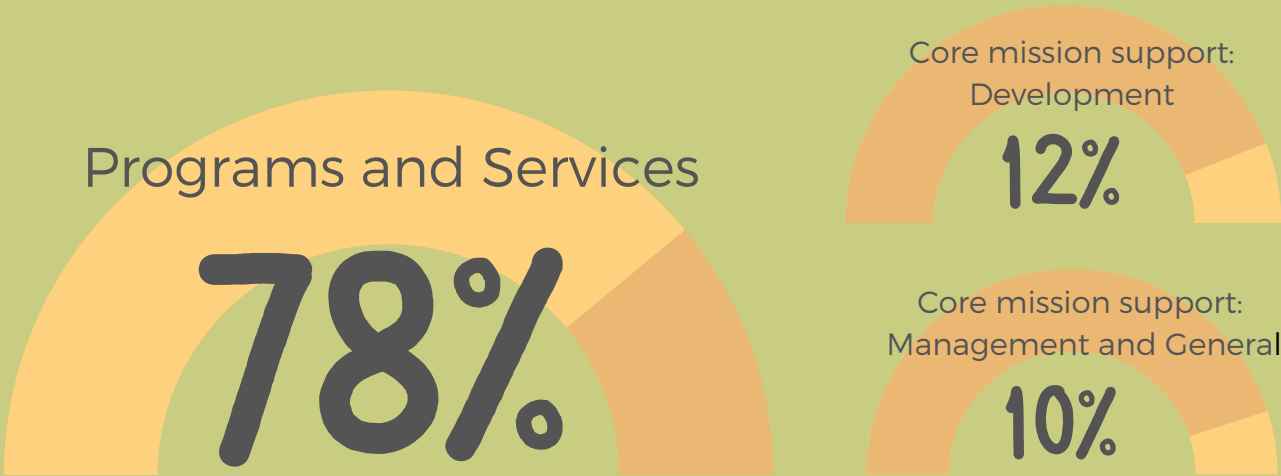
